In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to UNDP, and seek UNDP's confirmation on whether or not such a conflict exists.

Similarly, the Bidders must disclose in their proposal their knowledge of the following:

- a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel are family members of UNDP staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving services under this RFP; and
- b) All other circumstances that could potentially lead to actual or perceived conflict of interest, collusion or unfair competition practices.

Failure to disclose such an information may result in the rejection of the proposal or proposals affected by the non-disclosure.

The eligibility of Bidders that are wholly or partly owned by the Government shall be subject to UNDP's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFP, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the Proposal.

Proposers shall not be eligible to submit a proposal if at the time of proposal submission:

- is included in the Ineligibility List, hosted by <u>UNGM</u>, that aggregates information disclosed by Agencies, Funds or Programs of the UN System;
- is included in the <u>Consolidated United Nations Security Council Sanctions List</u>, including the UN Security Council Resolution 1267/1989 list;
- is included in the <u>World Bank Corporate Procurement Listing of Non-Responsible Vendors</u> and <u>World Bank Listing of Ineligible Firms and Individuals.</u>

### 5. Proprietary information

The RFP documents and any Terms of Reference or information issued or furnished by UNDP are issued solely for the purpose of enabling a proposal to be completed and may not be used for any other purpose. The RFP documents and any additional information provided to proposers shall remain the property of UNDP. All documents which may form part of the proposal will become the property of UNDP, who will not be required to return them to your firm.

#### 6. Publicity

During the RFP process, a proposer is not permitted to create any publicity in connection with the RFP.

Any request for clarification must be sent in writing in the manner indicated in Section 3: Data Sheet. Explanations or interpretations provided by personnel other than the named contact person will not be considered binding or official.

#### UNDP shall not be kept liable for any fluctuations of the exchange market during contract implementation, the Contractor being legally responsible to register any loss/gain of currency exchange resulting from payments against the Contract in accordance with the national legislation.

#### 15. Duties and taxes

Article II, Section 7, of the Convention on the Privileges and Immunities provides, inter alia, that the United Nations, including UNDP as a subsidiary organ, is exempt from all direct taxes, except charges for public utility services, and is exempt from customs restrictions, duties, and charges of a similar nature in respect of articles imported or exported for its official use. All proposals shall be submitted net of any direct taxes and any other taxes and duties, unless otherwise specified in Section 3: Data Sheet

## 16. Proposal validity period

Proposals shall remain valid for the period specified in Section 3: Data Sheet, commencing on the deadline for submission of proposals. A proposal valid for a shorter period may be rejected by UNDP and rendered non-responsive.

During the proposal validity period, the proposer shall maintain its original proposal without any change, including the availability of the key personnel, the proposed rates and the total price.

In exceptional circumstances, prior to the expiration of the proposal validity period, UNDP may request proposers to extend the period of validity of their proposals. The request and the responses shall be made in writing and shall be considered integral to the proposal.

If the proposer agrees to extend the validity of its proposal, it shall be done without any change to the original proposal but will be required to extend the validity of the proposal security, if required, for the period of the extension, and in compliance with Article 17 (Proposal security) in all respects.

The proposer has the right to refuse to extend the validity of its proposal without forfeiting the proposal security, if required, in which case, the proposal shall not be further evaluated.

## 17. Proposal security

A proposal security, if required by Section 3: Data Sheet, shall be provided in the amount and form indicated in the Section 3: Data Sheet. The proposal security shall be valid for a minimum of thirty (30) days after the final date of validity of the proposal.

The proposal security shall be included along with the proposal. If a proposal security is required by the RFP but is not found in the proposal, the offer shall be rejected.

If the proposal security amount, or its validity period, is found to be less than is required by UNDP, UNDP shall reject the proposal.

In the event an electronic submission is allowed in Section 3: Data Sheet, proposers shall include a copy of the proposal security in their proposal and the original of the proposal security must be sent via courier or hand delivery as per the instructions in Section 3: Data Sheet.

Unsuccessful proposers' proposal securities will be discharged/returned as promptly as possible but no later than thirty (30) days after the expiration of the period of proposal validity prescribed by UNDP pursuant to Article 16 (Proposal Validity Period).

The Proposal security may be forfeited by UNDP, and the proposal rejected, in the event



of any, or combination, of the following conditions:

- If the proposer withdraws its offer during the period of the proposal validity specified in Section 3: Data Sheet, or;
- In the event the successful Proposer fails:
  - o to sign the contract after UNDP has issued an award; or
  - to furnish the performance security, insurances, or other documents that UNDP may require as a condition precedent to the effectivity of the contract that may be awarded to the proposer.

#### 18. Joint Venture, Consortium or Association

If the proposer is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium or Association for the proposal, each such legal entity will confirm in their joint proposal that:

- they have designated one party to act as a lead entity, duly vested with authority
  to legally bind the members of the JV, Consortium or Association jointly and
  severally, and this will be evidenced by a duly notarised agreement among the
  legal entities, which will be submitted along with the proposal; and
- if they are awarded the contract, the contract shall be entered into by and between UNDP and the designated lead entity, who will be acting for and on behalf of all the member entities comprising the joint venture.

After the deadline for submission of proposal, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of UNDP.

If a JV, Consortium or Association's proposal is the proposal selected for award, UNDP will award the contract to the joint venture, in the name of its designated lead entity. The lead entity will sign the contract for and on behalf of all other member entities.

The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Article 19 (Only one Proposal) herein in respect of submitting only one proposal.

The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entities in the joint venture in delivering the requirements of the RFP, both in the proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by UNDP.

A JV, Consortium or Association, in presenting its track record and experience, should clearly differentiate between:

- Those that were undertaken together by the JV, Consortium or Association; and
- Those that were undertaken by the individual entities of the JV, Consortium or Association.

Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.

JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.

## 19. Only one proposal

The proposer (including the individual members of any Joint Venture) shall submit only one proposal, either in its own name or as part of a Joint Venture.

Proposals submitted by two (2) or more proposers shall all be rejected if they are found to have any of the following:



#### they have at least one controlling partner, director or shareholder in common; any one of them receive or have received any direct or indirect subsidy from the other/s; or they have the same legal representative for purposes of this RFP; or they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the proposal of another proposer regarding this RFP process; they are subcontractors to each other's proposal, or a subcontractor to one proposal also submits another proposal under its name as lead proposer; or some key personnel proposed to be in the team of one proposer participates in more than one proposal received for this RFP process. This condition relating to the personnel, does not apply to subcontractors being included in more than one proposal. 20. Alternative Unless otherwise specified in Section 3: Data Sheet, alternative proposals shall not be proposals considered. If submission of alternative proposals is allowed in Section 3: Data Sheet, a proposer may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. Where the conditions for its acceptance are met, or justifications are clearly established, UNDP reserves the right to award a contract based on an alternative proposal. If multiple/alternative proposals are being submitted, proposer must create an alternate response directly in the system and upload all attachments relevant to the alternate proposal separately together with the alternate response... 21. Pre-proposal When appropriate, a pre-proposal conference will be conducted at the date, time and conference location and according to any instructions specified in Section 3: Data Sheet. If it is stated in Section 3: Data Sheet that the pre-proposal conference is mandatory, a Proposer which does not attend the pre-proposal conference shall become ineligible to submit a proposal under this RFP. If it is stated in Section 3: Data Sheet that the pre-proposal conference is not mandatory, non-attendance shall not result in disqualification of an interested proposer. UNDP will not issue any formal answers to questions from proposers regarding the RFP or proposal process during the pre-proposal conference. All questions shall be submitted in accordance with Article 38 (Clarification of Proposals). The pre-proposal conference shall be conducted for the purpose of providing background information only. Without limiting Article 24 (Proposers responsibility) proposers shall not rely upon any information, statement or representation made at the pre-proposal conference unless that information, statement or representation is confirmed by UNDP in writing. Minutes of the pre-proposal conference will be disseminated as specified in Section 3: Data Sheet. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the minutes of the proposer's conference or issued/posted as an amendment to RFP. When appropriate, a site inspection will be conducted at the date, time and location and 22. Site inspection according to any instructions specified in Section 3: Data Sheet. If it is stated in Section 3: Data Sheet that the site inspection is mandatory, a proposer which does not attend the site inspection shall become ineligible to submit a proposal under this RFP. If it is stated in Section 3: Data Sheet that the site inspection is not mandatory, nonattendance, shall not result in disqualification of an interested proposer.



Proposers participating in a site inspection shall be responsible for making and obtaining any visa arrangements that may be required for the proposers to participate in a site inspection. #### **SECTION 5: TERMS OF REFERENCE**

#### A. Project Description

During 2024 – 2027, UNDP and UNICEF <u>are</u> jointly implementing the Project "Advancing Quality Education and Lifelong Learning Opportunities for All", funded by the European Union. The overarching objective of the project is to contribute to human capital development in the Republic of Moldova, improving the quality and relevance of education and lifelong learning opportunities for all, for better matching the labour market demands. To achieve this, the Program will target the following specific objectives:

- Strengthen institutions and system for teacher and school leaders' professional development and support the implementation of education policies to enhance quality of teaching and learning (Development Strategy "Education 2030".
- Improve equitable access for all children to quality education, promoting the development of an inclusive, digital, and resilient education system.
- Upgrade learning environments through renovation of selected school infrastructures and facilitate the
  development of the 21st century skills, contributing to better education opportunities for pupils/students
  and improved efficiency of the school network.

Under this joint Project, UNDP will support the professional development of teachers, promote life-long learning opportunities for adults, and be responsible for implementing interventions under the specific objective number 3 mentioned above, that aims at increasing quality, relevance, and efficiency of learning. More specifically, it will support Ministry of Education and Research in enhancing the learning environments and improving the teaching-learning conditions by setting up modern learning spaces, improvement of school infrastructure of 10 model/aspirational schools. It will also aim at redesigning existing STEEAM learning spaces to facilitate better learning, provision of modern technologies and teaching-learning resources and support the roadmaps for continuous development of digital learning space. The activities will ease the accessibility of students from remote areas to the model/aspirational schools through access to transportation means and development of an integrated national system for school bus management. In addition, this component aims at designing and rolling-out a digital transformation & STEEAM model in upper-secondary education focusing on teachers' mentorship in using new educational technologies, adopting new pedagogical approaches, support the development of digital educational resources for science disciplines, and support the capacity of school managers to embark upon the process of e-transformation in education.

#### **Model School Concept**

The "Model School" concept was launched by the Ministry of Education and Research (MER) in February 2024 and involves the renovation and endowment of 35 general schools across the country. The concept aims to ensure equitable access to quality education for all students, but especially for students in rural areas, by creating a stimulating learning environment that would foster the development of cognitive and socio-emotional skills.

The "Model School" concept was formulated based on the problem of low results of students from the Republic of Moldova at international and national assessments. Every second student in the Republic of Moldova does not reach the minimum level of competence in the international PISA assessment. Although, since the first participation in that assessment, the average score has increased, the last PISA 2022 edition has seen the results going down with the share of students who did not reach the minimum level of competence reached up to 55.8% in mathematics, 48.4% in reading and 48.5% in science.<sup>1</sup>

The monitoring measures of the gymnasium graduation exams, carried out by the MER and NACE<sup>2</sup> in over 180 institutions in 8 districts this year, have attested a decrease in the exam passing rate, in some districts the passing rate dropped by 36%, from 100% to 64%.

#### **Organizational Development**

The managers of the Model Schools are responsible for the development process of the institutions they lead and will direct the enactment of the mission they undertake as a Model School. Ensuring a stimulating learning

environment for all students, including students from rural areas who will be transferred to these schools, is the central mission of the Model Schools. All processes of infrastructure modernization, organizational development and teacher training will be aligned with the latter. The managers of the 10 model schools participating in the project will be supported in developing the skills necessary to lead and synchronize all these processes. The school principal shall become responsible for placing learning at the heart of the school's mission and translating the vision into strategy so that the organization's actions are consistent with its vision, goals and values. He or she will be supported for organizing work and administrative processes to facilitate professional dialogue, collaboration and knowledge sharing, all of which are essential for promoting change and innovation.

Recent UNICEF studies confirm the need to invest in the professional development of managers in the Republic of Moldova. Evidence suggests that in many cases they face difficulties in leading organizational development efforts, with most continuing to focus on traditional administrative and management tasks (UNICEF, 2019).

The "Advancing Quality Education and Lifelong Learning Opportunities for All" program will contribute to the Moldova National Development Strategy 2023 by modernizing education, improving infrastructure, and promoting inclusive learning environments. By transforming 10 schools into Model Schools with student centered design renovations, the program will enhance learning outcomes and equip students with 21st-century skills. It also supports school leadership through organizational development, ensuring effective change management. This aligns with the UN Strategic Plan Outcome 1 and UNDP CPD Outcome 2, focusing on human rights-based, gender-responsive services for all, especially the underserved. The program advances SDG 4 targets by providing free, quality education, improving skills for financial success, and upgrading inclusive schools.

#### B. Objectives of the assignment

UNDP Moldova intends to contract a specialized and experienced organization or a consortium of organizations (hereinafter "the service provider") to support 10 selected Model Schools in the articulation of the long-term vision, mission, development of their strategic plans and objectives, in a participatory manner, including teachers, students, parents, and wider community. Based on the Model School concept and the project objectives, the selected service provider will support 10 selected Model Schools with mentorship for the operationalization of one objective from the strategic development plan.

To achieve the above-mentioned scope, the following specific goals and tasks shall be carried out by the service provider:

- Conduct a school-level situational analysis for each of the 10 selected Model Schools, including desk
  review of internal data (current strategic plan, academic results, infrastructure, staffing, etc), focus group
  discussions and interviews with key stakeholders, SWOT analysis (or similar), to better understand the
  current situation, main challenges and priorities, and support strategic planning. The situational analysis
  must cover, at minimum, academic performance, teaching and staff capacity, school culture and
  environment, infrastructure and resources, internal processes and management/school governance.
- 2. Design and deliver a foundational training/workshop for managers and school leadership teams covering at least, but not limited to, topics such as: strategic planning, the role of inclusive, participatory planning in school development, examples and evidence of strategic planning impact in education from national and international contexts, change management, roles and responsibilities in the planning process, basics of stakeholder engagement, and other relevant topics to support the achievement of project objectives, The training will be delivered face to face, in two groups of 25 participants each, and will cover management teams comprised of schools administration and teachers from 10 Model schools, amounting to around 50 participants (5 participants, managers and teachers, per school). The service provider must include the proposed syllabus / outline of the training programme in the proposal. The selected company will assume all the expenses related to the entire organization of the workshops, including printing, transportation, logistics, catering. A minimum of three full days (equivalent to 24 hours) of training or workshops will be conducted with physical presence. The accommodation expenses shall be covered for two nights for all participants. Additional online sessions may be proposed by the contractor.
- 3. Facilitate a series of **strategic planning workshops** with each school, helping them identify motivations and priorities, ensuring vision and mission development/refinement, strategic priorities and goals, map challenges, drafting of key objectives and outcomes, and preliminary action planning. Support the



finalization and validation of the school's strategic development plans, ensuring a clear structure, alignment with national educational policies and Model School concept, realistic objectives and defined indicators and timelines, as well as ensuring the buy-in from all stakeholder groups: teachers, students, parents, and wider community. At least two days (16 contact hours) of workshops with physical presence and at least eight online individual coaching sessions (16 online contact hours) with each school team should be envisaged for this activity.

- 4. Guide schools with the selection of one objective for implementation. Facilitate planning workshops focused on the selected objective, resulting in detailed activity planning, distribution of roles, setting of timelines and allocation of resources, as well as monitoring and success indicators. Provide mentoring and support in the operationalization of the selected objective, including regular check-ins and coaching calls, troubleshooting and problem-solving support, advise on the mobilization of local support and resources. At least eight online individual coaching sessions (16 online contact hours) with each school team should be envisaged for this activity.
- 5. Support the creation of a **dialogue platform** among the 10 Model Schools, aimed at supporting school managers to share best practices related to promoting innovative teaching and learning practices which facilitate stimulating and collaborative learning environment (in total for up to 70 participants). Organize one event with physical presence for school managers for sharing good practices among the participating schools.
- 6. **Develop a report on the implemented activities** with specific information on the challenges, conclusions and recommendations on further needed support for the 10 Model Schools.

#### D. Institutional arrangements

The Contractor will be awarded a contract with UNDP for the delivery of services applied for and will work under the overall supervision of UNDP Project team.
