1. Scope	<p>Proposers are invited to submit a proposal for the services specified in Section 5: Terms of Reference, in accordance with this Request for Proposal (RFP). A summary of the scope of the proposal is included in Section 3: Data Sheet.</p> <p>Proposers shall adhere to all the requirements of this RFP, including any amendment made in writing by UNDP. This RFP is conducted in accordance with Policies and Procedures of UNDP which can be accessed at UNDP Programme and Operations Policies and Procedures/Procurement.</p> <p>As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website (www.ungm.org). The Bidder may still submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM prior to contract signature.</p>
2. Interpretation of the RFP	<p>Any proposal submitted will be regarded as an offer by the proposer and does not constitute or imply the acceptance of the proposal by UNDP. UNDP is under no obligation to award a contract to any proposer as a result of this RFP.</p>
3. Supplier Code of Conduct, Fraud, Corruption, Gifts and Hospitality	<p>All proposers must read the United Nations Supplier Code of Conduct and acknowledge that it provides the minimum standards expected of suppliers to the UN. Proprietary information</p>	<p>The RFP documents and any Terms of Reference or information issued or furnished by UNDP are issued solely for the purpose of enabling a proposal to be completed and may not be used for any other purpose. The RFP documents and any additional information provided to proposers shall remain the property of UNDP. All documents which may form part of the proposal will become the property of UNDP, who will not be required to return them to your firm.</p>
<p>6. Publicity</p>	<p>During the RFP process, a proposer is not permitted to create any publicity in connection with the RFP.</p>

7. Clarification of solicitation documents	<p>Proposers may request clarifications on any of the RFP documents no later than the date indicated in Section 3: Data Sheet. Any request for clarification must be sent in writing in the manner indicated in Section 3: Data Sheet. Explanations or interpretations provided by personnel other than the named contact person will not be considered binding or official.</p> <p>UNDP will provide the responses to clarifications through the method specified in Section 3: Data Sheet.</p> <p>UNDP shall endeavour to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of UNDP to extend the submission date of the proposals, unless UNDP deems that such an extension is justified and necessary.</p>
8. Amendment of solicitation documents	<p>At any time prior to the deadline for proposal submission, UNDP may for any reason, such as in response to a clarification requested by a proposer, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective proposers.</p> <p>If the amendment is substantial, UNDP may extend the deadline for submission of proposals to give the proposers reasonable time to incorporate the amendment into their proposal.</p>

9. Cost of preparation of proposal	The proposer shall bear all costs related to the preparation and/or submission of the proposal, regardless of whether its proposal is selected or not. UNDP shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.
10. Language	The proposal, as well as any and all related correspondence exchanged by the proposer and UNDP, shall be written in the language(s) specified in Section 3: Data Sheet.
11. Documents establishing eligibility and qualifications of the proposer	The proposer shall furnish documentary evidence of its status as an eligible and qualified vendor, using the forms provided in Section 7 and providing the documents required in those forms. In order to award a contract to a proposer, its qualifications must be documented to UNDP's satisfaction.

12. Technical proposal format and content	<p>The proposer is required to submit a technical proposal using the forms provided in Section 7 and taking into consideration the requirements in the RFP.</p> <p>The technical proposal shall not include any price or financial information. A technical proposal containing material financial information may be declared non-responsive.</p>
13. Financial proposal	<p>The financial proposal shall be prepared using the form provided in Section 7 and taking into consideration the requirements in the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.</p> <p>Any output and activities described in the technical proposal but not priced in the financial proposal, shall be assumed to be included in the prices of other activities or items as well as in the final total price.</p> <p>Prices and other financial information must not be disclosed in any other place except in the financial proposal.</p>

14. Currencies	<p>All prices shall be quoted in the currency or currencies indicated in Section 3: Data Sheet. Where proposals are quoted in different currencies, for the purposes of comparison of all proposals:</p> <ul style="list-style-type: none"> • UNDP will convert the currency quoted in the proposal into the UNDP preferred currency, in accordance with the UN Operational Rate of Exchange. • In the event that UNDP selects a proposal for award that is quoted in a currency different from the preferred currency in Section 3: Data Sheet, UNDP shall reserve the right to award the contract in the currency of UNDP's preference, using the conversion method specified above.
15. 16. Proposal validity period	<p>Proposals shall remain valid for the period specified in Section 3: Data Sheet, commencing on the deadline for submission of proposals. A proposal valid for a shorter period may be rejected by UNDP and rendered non-responsive.</p> <p>During the proposal validity period, the proposer shall maintain its original proposal without any change, including the availability of the key personnel, the proposed rates and the total price.</p> <p>In exceptional circumstances, prior to the expiration of the proposal validity period, UNDP may request proposers to extend the period of validity of their proposals. Only one proposal</p>	<p>The proposer (including the individual members of any Joint Venture) shall submit only one proposal, either in its own name or as part of a Joint Venture.</p> <p>Proposals submitted by two (2) or more proposers shall all be rejected if they are found to have any of the following:</p> <ul style="list-style-type: none"> • they have at least one controlling partner, director or shareholder in common; or • any one of them receive or have received any direct or indirect subsidy from the other/s; or • they have the same legal representative for purposes of this RFP; or • they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about, or influence on the proposal of another proposer regarding this RFP process. • they are subcontractors to each other's proposal, or a subcontractor to one proposal also submits another proposal under its name as lead proposer; or some key personnel proposed to be in the team of one proposer participates in more than one proposal received for this RFP process. SECTION 5. TERMS OF REFERENCE

RFP25/03179: Development of Curriculum on Water Reservoir Management and Training of Reservoir Owners in the Dniester River Basin District

Project: “Supporting the Moldovan authorities in the sustainable management of the Dniester River” Project/Dniester 2

1. BACKGROUND

Sustainable management of water resources in accordance with the principle of integrated water management is a priority for Moldova. For further development of the water policy and improvement of the regulatory framework, the Ministry of Environment (MoE), with the support of its subordinated institutions, is responsible for ensuring an ongoing dialogue with the neighboring countries on the integrated management of transboundary water resources, with the goal to ensure the quality and quantity of water needed for both sustainable socio-economic development of the country and a healthy environment.

In the process of improvement of the national regulatory framework, and harmonization of the environmental legislation with the provisions of European Union (EU) directives, the national environmental protection system faces many constraints, particularly, related to outdated standards, normative acts, capacity of responsible institutions, shortage of qualified staff in the government sectoral institutes, etc.

The importance of integrated management of the Dniester River is indisputable for the Republic of Moldova. It is the largest river in the Republic of Moldova, covering 70% of the country's water consumption needs, thus being considered a strategic surface water resource for both environmental and socio-economic security of the country.

According to Water Law no. 272/ 2011, the river basin district management plans (RBDMP) are being developed for a 6-year cycle. It shall be mentioned that the Ukrainian side is also concerned with the development of the Dniester River Basin Management Plan (RBMP) for the years 2025-2030. In that sense, important methodological aspects were harmonized between countries' experts and institutions, and a Joint Strategic Action Program had been elaborated with assistance of the GEF funded project. The Strategic Action Program (SAP) is one of the key strategic documents of the Commission on Sustainable Use and Protection of the Dniester River Basin. It is based on the findings of the Transboundary Diagnostic Analysis (TDA) for the Dniester River Basin. Both documents have been developed according to the methodology agreed by the two countries and have been extensively consulted. The documents contribute to the Dniester River basin management planning at the national level, as well as support implementation of international commitments to develop joint plans for the transboundary basins. On March 31, 2021, there was signed a Joint Statement on the approval of the Strategic Action Program for the Dniester River Basin for 2021 between the Ministry of Agriculture, Regional Development and Environment of the Republic of Moldova and the Ministry of Environmental Protection and Natural Resources of Ukraine.

Along with attempts to solve the cross-border aspect of the Dniester River management on the platform of the Dniester Commission, currently, the environmental institutions are in an extensive process of functional analysis aimed at streamlining the structure, functions, and capacities in the field of integrated management of water resources.

The strategy of the project “Support to the Moldovan authorities for the sustainable management of the Dniester River” is to improve environmental and social conditions in the Dniester River Basin District through enhanced management of water resources on the basis of updated regulatory framework, comprehensive and reliable river basin management planning, improved water management institutional capacities and implementation of practical environmental activities that would improve the ecological status of the Dniester River, identified as part of the Dniester Impact Study (2021).

The Overall Objective of the Dniester 2 project is to increase the capacity of the Moldovan Government to sustainably manage the Dniester River basin at the national and transboundary levels, including:

- To ensure that Moldova has a sufficient regulatory framework for sustainable river management based on the basin-wide approach supported by the WFD provisions,

- To provide the Moldovan Government with a comprehensive and realistic Management Plan for the Dniester River Basin developed in compliance with the WFD,
- To provide continuous support for the enhancement of capacities of national authorities responsible for water management, as well as the Moldovan representatives under joint Moldovan and Ukrainian bodies tasked with cross-border management of the Dniester River
- To improve the social, economic, and environmental conditions of the Dniester River.

As part of its support to strengthen water governance and improve legal and institutional frameworks, the Dniester 2 project contributed to the development and promotion of Government Decision No. 403 of 05 July 2024, which approved the Regulation on the Use and Management of Water Fund Lands and Hydraulic Structures. This Regulation establishes clear procedures for the allocation, use, lease, and sublease of state-owned water fund lands and hydraulic infrastructure, promoting legal certainty, environmental responsibility, and improved coordination between public and private stakeholders. It also provides mechanisms to ensure public access to water bodies and alignment with national policies on environmental protection, water management, and land-use planning.

Another important ongoing activity under the Dniester 2 project focuses on the finalization and official approval of a Methodology for the controlled liquidation of ponds and reservoirs deemed at high risk of collapse or no longer serving their intended function. An initial draft of this Methodology was developed under the previous SDC/ADA project *“Strengthening the Institutional Framework in the Field of Water Resources in the Republic of Moldova”*. However, the methodology requires significant updates to ensure full compliance with Moldova’s national legal framework, including the Water Law No. 272/2011 and urban planning regulations. The current intervention supports the Government of the Republic of Moldova by providing technical expertise to refine the Methodology, align it with institutional mandates, and assess its regulatory impact. The activity also includes facilitation of the stakeholder consultation process and preparation for formal adoption through a Government Decision. Once approved, this Methodology will offer a legally sound and technically robust tool for identifying and safely decommissioning non-functional or environmentally hazardous reservoirs, thus contributing to improved safety, ecological health, and more effective water resource management in the Dniester River Basin and nationwide.

The project is being implemented through August 2022 - April 2027.

2. OBJECTIVES OF THE ASSIGNMENT

The overarching objective of this assignment is to develop a practical and standardized training curriculum on the management of lakes and reservoirs, and to deliver targeted capacity-building sessions for both public and private owners within the Dniester River Basin District. The training will aim to strengthen the technical competencies and operational practices of reservoir owners, focusing on essential areas such as structural integrity, maintenance routines, water quality protection, and legal compliance. This capacity development effort is aligned with the broader goal of promoting sustainable, safe, and environmentally sound water infrastructure management in the context of Moldova’s growing water security challenges.

In recent decades, human pressure on Moldova’s water resources has increased significantly, particularly in small and medium-sized river basins. Intensified agricultural activity over the past seventy years has contributed to the degradation of natural watercourses, while the mounting effects of climate change and regional aridity have exacerbated water scarcity. In response, numerous water reservoirs have been constructed across the country to serve a range of economic functions, including irrigation, fish farming, and recreation, while also playing a role in river flow regulation and flood mitigation. Despite their socio-economic relevance, these reservoirs—often built by damming watercourses—also pose serious ecological and hydrological challenges.

The construction of reservoirs through river damming alters natural hydrological regimes, impacting water flow continuity, aquatic biodiversity, and sediment transport. These impacts are not confined to the reservoir itself but cascade across upstream and downstream areas. Reduced river runoff, stagnant flow within lakes, and sediment accumulation are common consequences. These effects weaken ecosystem resilience and diminish the ecological services provided by natural water systems. In this context, proper technical and operational management of reservoirs is critical not only for maintaining water availability but also for safeguarding downstream ecosystems and reducing the risk of dam-related hazards.

According to official estimates, the total number of hydrotechnical constructions (primarily dams) across the Republic of Moldova was approximately 3,800–4,000 as of 2018. In response to the need for updated and centralized data, the National Authority "Apele Moldovei" initiated a comprehensive inventory process in 2019 under the SDC/ADA project. The goal was to include all dams in Moldova's hydrographic districts in the Automated Information System "State Water Cadastre." While the SDC/ADA project initially planned to inventory around 1,800 dams within the Dniester River Basin District through on-site visits, the application of GIS technologies, satellite imagery, and orthophoto analysis enabled identification of a total of 3,661 dam-like hydrotechnical constructions. Of these, 2,074 dams—representing 56.6% of the total identified—were successfully inventoried in the central and northern sub-basins of the Dniester. Building on this effort, the Dniester 2 project aims to complete the inventory by covering the remaining dams through topographic surveys and integrating the newly gathered data into the State Water Cadastre. Ensuring the completeness, accuracy, and accessibility of this inventory is essential for guiding future interventions in reservoir safety, maintenance, and legal compliance.

Unfortunately, many reservoirs in Moldova are not operated in compliance with national technical standards or environmental regulations. A significant number lack basic hydraulic infrastructure such as bottom outlets or sluices, which are required to release water downstream. As a result, the natural continuity of river flows is often disrupted, leading to the desiccation of downstream segments and reduced availability of water for ecosystems and communities. This non-compliance contributes to cumulative environmental stress in the Dniester River Basin and contradicts both legal obligations and best practices in integrated water resources management.

Compounding the issue, many reservoir owners, both private and public, do not possess or implement formal operational regulations. According to the National Authority "Apele Moldovei," only 371 reservoirs in the Dniester Basin District have registered operational regulations in accordance with Government Decision No. 977/2016, which requires all reservoir owners to establish standardized procedures for safe and responsible operation. Without such frameworks, many reservoirs fail to perform the functions for which they were originally constructed and may pose environmental or structural risks, particularly during extreme weather events.

The training program envisioned under this assignment should be designed to directly address these gaps. By providing practical guidance and capacity development on reservoir operation, maintenance, and regulatory compliance, the program will equip owners and managers with the tools and knowledge they need to ensure water infrastructure is safe, functional, and ecologically sustainable. The training program will be delivered to 100 reservoir owners, ensuring geographic coverage and representation across the Dniester River Basin District.

To ensure relevance and applicability, the training curriculum shall be grounded in the existing legal and institutional framework governing the management and operation of lakes and water reservoirs in the Republic of Moldova. This alignment will enable participants to better understand their legal obligations, integrate regulatory requirements into daily operations, and enhance coordination with competent authorities. The curriculum will incorporate core provisions from key normative acts, including but not limited to:

- Water Law No. 272/2011, particularly provisions on water use, reservoir operation, and ecological flow;
- Government Decision No. 977/2016 on the approval of the standard Regulation for the operation of reservoirs and ponds;
- Government Decision No. 403/2024 on the use and management of water fund lands and hydrotechnical structures;
- Relevant sections of the Civil Code CC1107/2002, including property rights and liability of infrastructure owners;
- Provisions of the Urbanism and Construction Code CUC434/2023 related to hydrotechnical infrastructure;
- Provisions of the Law No. 271/1994 on Civil Protection related to requirements for emergency preparedness and response planning and coordination with civil protection authorities in case of risk scenarios.

Ultimately, the assignment will contribute to the long-term resilience and functionality of small and medium-sized reservoirs in the Dniester River Basin District. Well-informed and trained reservoir owners will be better positioned to prevent infrastructure failures, manage water sustainably, and contribute to biodiversity protection and climate change adaptation.

3. TASKS TO BE PERFORMED UNDER THE ASSIGNMENT

The Contractor will be responsible for the design, development, and delivery of a comprehensive training program on the management of lakes and water reservoirs for both public and private owners operating within the Dniester River Basin District. The assignment will be carried out in close coordination with the staff of the Directorate for Integrated Water Resources Management Policies of the Ministry of Environment and of the National Authority „Apele Moldovei”. The key tasks include:

Task 1: Design of the Training Curriculum

1.1. Design a structured, modular training curriculum composed of six thematic modules, tailored to the technical and institutional realities of reservoir management in Moldova that includes:

- Principles of sustainable reservoir operation and maintenance
